SUBJECT: "SHINING PATH" THREAT ON PERUVIAN MISSION

1. PMUN SECOND SECRETARY DAVID MALAGA NOTIFIED USUN ON JUNE 10, 1987, THAT A CONFIDENTIAL TELEX FROM FORMIN INDICATED THERE WAS "CLEAR EVIDENCE" THAT THE "SHINING PATH" PLANNED TO TAKE SOME "ACTION" AGAINST THE PMUN. THE TELEX DID NOT SPECIFY THE TYPE OF ACTION NOR GIVE ANY TIME FRAME, HOWEVER, JUNE 18 IS FIRST ANNIVERSARY OF PRISON RIOT IN WHICH 200 SHINING PATH MEMBERS KILLED. PMUN REQUESTING INFORMATION/SUGGESTIONS IN IMPROVING THE SECURITY OF THEIR PREMISES.

2. USUN MISOFF ARRANGED FOR NYPD/FBI JOINT TERRORIST TASK FORCE (TTF) CONTACT WITH PMUN AS WELL AS COMPLETE SECURITY SURVEYS OF ALL PERUVIAN GOVERNMENT OFFICES (TO INCLUDE RESIDENCES OF PERM REP AND CONGEN) FOLLOWING TTF CONTACT AND EVALUATION. ADDITIONAL PRECAUTIONS MAY BE ESTABLISHED.

3. DSS/NYFO, IN ADDITION TO NYPD AND FBI, HAS BEEN ADVISED.
