Before DEA can begin processing your request, it will be necessary for you to provide a signed, notarized statement authorizing the release of information pertaining to the subject of your request. A form is enclosed to assist you in complying with this requirement. Before DEA can begin processing your request, it will be necessary for you to submit a notarized copy of the subject's death certificate or a newspaper account of the subject's death. This procedure is designed to insure that the subject is in fact deceased and that information regarding him is properly identified. Your recent correspondence does not reasonably describe any records within the meaning and intent of the Freedom of Information Act (5 USC 522). A better description is needed to enable agency personnel to locate the records with a reasonable amount of effort. The Act does not require an agency to either create new records, answer questions posed by requesters, or attempt to interpret a request that does not identify specific records. Please reformulate your request in accordance with 28 CFR 16.3 (b). The assistance of DEA Freedom of Information personnel is available to help you do this. Before DEA can begin processing your request, it will be necessary for the individual in whose name the telephone is officially listed to provide a signed, notarized statement authorizing the release of information to you. A form is enclosed to assist you in complying with this requirement. Also, please include a photo copy of the notification letter sent by the telephone company if you have not already provided it to DEA. If the deficiencies noted in this letter are not corrected within thirty days, your request to the Drug Enforcement Administration will be administratively closed.
