- 2. (U) TWO UNIDENTIFIED GUNNEN ASSASSINATED ICA DEPARTMENT PREFECT MANUEL SANTANA CHIRI THE NIGHT OF MARCH 24 IN FRONT OF HIS HOME IN THE CITY OF ICA. ABOUT SEVENTY YEARS OLD, SANTANA HAD BEEN IN APRAFOR FORTY YEARS.
- 3. (LOU) COMMENT: SL PROBABLY CARRIED OUT BOTH SETS OF ATTACKS, WHICH FIT STANDARD SL URBAN TACTICS, AND ARE CONSISTENT WITH SL'S ANTI-APRA PATTERN. THE ICA ASSASSINATION IS SIGNIFICANT BECAUSE IT MAY PRESAGE INCREASED SL ACTIVITY IN THE REGION IMMEDIATELY TO THE SOUTH OF LIMA DEPARTMENT.
