2. (LOU) COMMENT: ABOUT 80 MILES SOUTHEAST OF THE CITY OF CUZCO, SICUANI PROVINCE BORDERS THE PROVINCE OF MELGAR IN PUNO DEPARTMENT, AN AREA WHERE SL HAS INCREASED ACTIVITY RECENTLY. AS FAR AS WE KNOW, THIS IS THE FIRST MAJOR TERRORIST ATTACK IN SICUANI. BOTH SICUANI AND MELGAR PROVINCES (AND NEIGHBORING AZANGARO PROVINCE) CONTAIN SECTIONS OF THE IMPORTANT CUZCO-PUNO RAILROAD AND HIGHWAY. JORDAN
