2. REFTEL ADVISED OF 4/9 ARREST OF A MAN PRESUMED TO BE SURVEILLING THE U.S. CHANCERY. INDIVIDUAL CLAIMED TO BE A MEMBER OF THE SEN- DERO LUMINOSO (SL), AND POLICE PROCEEDED ON THE ASSUMPTION THAT HE WAS, IN FACT, AFFILIATED WITH THIS TERRORIST GROUP. BY MORNING OF 4/10, HOWEVER, DIRCOTF COMMANDER ADVISED EMBASSY THAT, DUE TO INCON- SISTENCIES IN SUSPECT'S STORY, AND DEMONSTRATED INCOHERENCY AND CON- FUSION, THEY NO LONGER FEEL THIS TO BE THE CASE. SUSPECT HAS BEEN REMANDED TO A POLICE HOSPITAL FOR PSYCHIATRIC EVALUATION.
