PERU'S ASSOCIATION OF DEMOCRATIC LAWYERS (AAD), A SENDERO LUMINOSO (SL) FRONT GROUP THAT DEFENDS SL PRISONERS, ISSUED A COMMUNIQUE LAST WEEK IN THE FAR LEFT PRESS ON THE REPORTED EXPULSION OF SEVEN PERUVIANS FROM SWEDEN. THE AAD "CONDEMNED AND REJECTED" THE SWEDISH DECISION AS CONTRAVENING THE UNIVERSAL DECLARATION OF HUMAN RIGHTS AND THE AMERICAN CONVENTION ON HUMAN RIGHTS. THE AAD SAID THAT THE EXPULSION OF THESE "FELLOW CITIZENS" WOULD BE TO "PUSH THEM TOWARDS TORTURE, PRISON, AND DEATH...BEARING IN MIND THAT SEVERAL OF THE ASYLEES (SIC) HAVE BEEN DETAINED PREVIOUSLY IN PERU."
