1. AUGUST 16 EDITION OF LIMA DAILY "PRENSA" CARRIES UPI DISPATCH FROM COPENHAGEN ON REPORT ISSUED BY AMNESTY INTERNATIONAL ON PERU AND SURINAME. BRIEF "PRENSA" PIECE REFERS TO HUMAN RIGHTS VIOLATIONS ALLEGEDLY COMMITTED BY PERUVIAN SECURITY SERVICES IN COURSE OF FIGHT AGAINST SENDERO LUMINOSO (SL) TERRORISTS.
