SUBJECT: RECENT DEVELOPMENTS IN THE EMERGENCY ZONE

REF: (A) LIMA 2074: N(B) LIMA 2379 (C) 83 LIMA 12915 V

I. (C) SUMMARY: GOP AUTHORITIES IN LIMA "EXPANDED" THE SOUTH-CENTRAL SIERRA EMERGENCY ZONE (EZ) AFFECTED BY SENDERO LUMINOSO (SL) TERRORISM TO INCLUDE A THIRTEENTH PROVINCE-THE CARVED OUT OF TERRITORY ALREADY IN THE ZONE. IN AYACUCHO.
MILITAARY AUTHORITIES SUSPENDED CURFEW THAT HAD BEEN IN EFFECT SINCE MARCH 1982. CURFEW SUSPENSION, ALONG WITH ERTAIN OTHER MEASURES, TESTIFIES TO IMPORTANCE NEW FOLITICAL MILITARY COMMANDER GENERAL HUAMAN ATTACHES TO IMPROVING ZONE POPULATIONS'S PHYSICAL AND ECONOMIC SE(RUITY. ALTHROUGH RANSE OF GOP CONTINUAN AND MILITARY EADERS IS REFERRING TO ENTIRE SECURITY.

CANNOT THRER FORE CONFIRM THAT ZONE SECURITY IMPORVEMENT IS DRAMATIC. ALTHOUGH OUT IMPRESSION IS THAT CONTINUING DETERIORATION TO WHICH HUAMAN PREVIOUS Y REFERRED HAS BEEN ARRESTED. BUT IT DOES SEEM CLEAR THAT OVERALL EZ HUMAN RIGHTS SITUATION HAS IMPROVED. LEFT OPPOSTION CONTINUES TO REPORT ON RIGHTS ABUSES. BUT SHOWS RESPECT FOR HUAMAN AND IS GIVING HIN BENEFIT OF DOUBT.

2. (U) EMERGENCY ZONE "EXPANDS." GOP "SUPREME DECREE"
DATED HARCH 16 EXPANDED EMERGENCY ZONE TO INCLUDE NEWLY
CREATED PROVINCE OF CHINCHEROS (DEPARTMENT OF APURIMAC).
EZ NOW COVERS TOTAL OF THIRTEEN PROVINCES INTHREE
DEPARTMENTS" SIX OF SEVEN IN AYACHCHO (CANGALLO, HUAMANGA.
HUANTA, LA MAR, JUCANAS, VICTOR FAJARDO): TWO OF SEVEN IN
APURIMAC (ANDAHUAYLAS, CHINCHEROS); AND ALL FIVE IN
HUANCAVELICA (ACOBAMBA, NAGARAES, CASTROVIRREYNA,
HUANCAVELICA (ACOBAMBA, NAGARAES, CASTROVIRREYNA,
HUANCAVELICA, TAYACAJA). COMMENT: LAW THAT CREATED
NEW PROVINCE OF CHINCHEROS ON DECEMBER 30, 1983 CARVED
IT OUT OF PROTION OF PREEXISTING PROVINCE OF ANDAHUAYLAS.
WHICH ALREADY WAS PART OF ZONE. SUPREME DECREE THEREFORE DOES NOT SO MUCH "EXPAND" XONE AS CLARIFY LEGAL
LIMBO OF NEW PROVINCE, WHICH WAS NOT MENTIONED WHEN GOP
LAST EXTENDED DURATION OF STATE OF EMERGENCY OR EXPANDED
AREA COVERED BY IT(REF B).

3. (U) CURFEW SUSPENDED IN AYACHCHO. EZ'S POLITICAL MILITARY COMMAND SUSPENDED, EFFECTIVE MARCH 18, CURFEW THAT HAD APPLIED IN CITY OF AYACHCHO SINCE SL ATTACK OF MARCH 2-3, 1982, ON CITY'S JAIL. MAYOR GOP AND CONGRESSIONAL FIGURES HAILED CURFEW'S LIFTING AS EVIDENCE OF A SIGNIFICANT IMPORVEMENT INOVERALL EZ SECURITY CONFIDENTIAL

SITUATION. (SOME LOCAL NEWSPAPERS AND INTERNATIONAL WIRE SERVICES HISTAKENLY REPORTED THAT CURFEW LIFTING APPLIED TO WIDER AREA THAN JUST CITY OF AYACHCHO). CORRESPONDENTS IN CITY REPORTED HARCH, 19 THAT SL HAD RESPONDED BY DISTRIBUTING LEAFLETS DECLARING THAT JERRORISTS WOUND NOT REPEAT NOT END THE REVOLUTION END.

Y. (C) HUAMAN'S STRATEGY. CURFEW LIFGING APPREARS TO BE PART OF OVERALL STRATEGY BEING PURSUED BY NEW ZONE POLITICAL MILITARY COMMANDER, GENERAL ADRIAN HUAMAN.

IN LINE WITH IDEAS PREVIOUSLY OUTLINED (REF C). HUAHAN IS DEVOTING INCREASED IMPORTANCE TO ZONE POPULATIONS'S PHYSICAL AND ECONOMIC SECURITY. LANGUAGE OF COMMUNIQUE LIFTING CURFEW JUSTIFIED ACTION ON CONTRIBUTION IT WOULD MAKE TOWARD "GUARANTEEING THE NORMAL DEVELOPMENT" OF PUBLIC'S ACTIVITIES (I.E., NO REPEAT NO LINKAGE TO AN IMPRQUED SECRUITY SITUATION). IN REMARKS TO REPORTERS AT HID-MONTH. HUMMAN SPOKE SHARPLY ABOUT NEED TO AUGHENT ANTITERRORIST MEASURES WITH SIGNIFICANT ECONOMIC DEVLOOPHENT EFFORT. HUAMAN ALSO REFERRED PUBLICLY TO NEED TO CURB ABUSES COMMITTED BY SECURITY FORCES, PARTICULARLY THE POLICE. HUMMAN RELATED THAT HE HAD PERSONALLY INSPECTED AVACHCHO JAIL AND DETERMINED THAT SEVERAL OF INTERNEES THERE WERE BEING WRONGFULLY HELD. HE ASSERTED THAT HE HAD ORDERED THEIR REMOVAL, AND THEY SUBSEQUENTLY WERE FREED. HUAMAN ALSO HAS GONE OUT OF HIS WAY TO ENSURE A SUCCESSFUL HOLY WEEK IN AYACHUCHO. MEETING WITH CHURCH AND LOCAL PLANNERS, OFFERING A HILITARY BAND AND EMPHASIZING THAT TO ACCOMPANY RELIGIOUUS PROCESSIONS. SECURITY FORCES WILL PROTECT TOURISTS COMING TO CITY FOR FESTIVITIES. (COMMENT: HISTORICALLY A TOURIST FOCAL POINT, AYACUCHO HAS SEEN THIS MAJOR INDUSTRY DRY UP AND ALL BUT DISAPPEAR BECAUSE OF TERRORIST VIOLENCE.)

DEPARTMENT. BUT ON MARCH 16. POLITICAL MILITARY COMMANDER FOR THAT PART OF DEPARMENTANNOUNCED THAT. HENCE FORTH. SECURITY FORCES WOULD MAKE ARRESTS ONLY FOR PROBABLE CAUSE. AND ONLY BETWEEN 6 A.M. AND SPM. NEW POLICY WAS EXPARINED IN TERMS OF AVOIDING ARBITRARY ACTIONS AGAINST DETAINEES AND IN ORDER TO PERMIT PUBLIC TO BE AWARE OF DEVELOPMENTS.

6. (U) INTERIOR MINISTER PERCOVICH AGREED ON MARCH 19
WITH HUMMAN'S CALL FOR GREATER DEVELOPMENT ACTIVITY IN
ZONE. HE ASSERTED. HOWEVER, THAT PREVIOUS GOP. EFFORTS
WERE STYMIED BY SL ATTACKS: ON GOVERNMENT PERSONNIEL AND
EQUIPMENT. PERCOVICH SASO DOP: DEVELOPMENT CTIVITY MOULD
"INTENSIFY" AS PACIFICATION OF REGION CONTINUED.

7. (C) COMMENT: HUAMAN, PERCOVICH, AND OTHER GOP

SPOKESMEN HAVE ALL REFERRED IN RECENT DAYS TO "IMPROVED SECURITY SITUATIONS" IN ZONE. THEIR ASSERTIONS HAVE COME ACCOMPANIEED, HOWEVER, BY RENEWED REPORTS OF SL VIOLENCE, INCLUDING HLTIPLE DYNAMITE EXPLOSIONS AND ELECTRICAL BLACKOUTS IN CITY OF AYACUCHO ITSELF, ASSASSINATION OF CIVILITANS, AND ATTACKS ON POLICE STATIONS AND MINES (WHERE DYNAMITE FOOD AND MEDICAL SEPPLIES WERE LOOTED). HISSION THEREFORE IS NOT REPEAT NOT ABLE TO CONFIRM THAT ZONESECURITY IMPORVEMENT IS DRAMATIC. ON OTHER HAND, HOWEVER, IT SEEMS CLEAR THAT CONTINUING DETERIORATION IN ZONE ABOUT WHICH HUMMAN SPOKE (REF C) HAS BEEEN AT LEAST TEMPORARILY ARRESTED.

8. (C) IT ALSO SEEMS CLEAR THAT OVERALL MUMAN RIGHTS
SITUATION IN EZ SHOWS IMPROVEMENT. OPPOSITION LIMA PRESS
CONTINUES TO CARRY REPORTS OF DISAPPEARANCES ("DESAPARECIDOS")
FOR WHICH SECURITY FORCES ARE ALLEGEDLY RESPONSIBLE.

CAYACUCHO DISTRICT ATTORNEY BENJAMIN MADUENO STATED IN A MARCH 19 PRESS CONFERENCE THAT IN SOME 650 INVESTIGATIONS CONFIRMED THE DISAPPEARANCE OF PERSONE SECURITY FORECES HAD DETAINED.) THESE REPORTS APPEAR TO FALL INTO TWO CATEGORIES: THOSE OCCURING BEFORE HUANAN ASSUMED COMMAND (AJAUARY 1, 1984) AND THOSE OCCURING SINCE. BULD OF CASES OBVIOUSLY LIE IN FIRST CATEGORY. FOR WHICH HUAMAN IS NOT RESPONSIBLE. AS FOR SECOND CATEGORY, OPPOSITON PRESS APPEARS TOACCEPT AT FACE VALUE HUAMAN'S ASSURANCES THAT HE IS ATTEMPTING TO CURB EXCESSES AND IS COOPERATING WITH PROSECUTING AND JUDICIAL AUTHORITIES ATTEMPTINNG TO IDENTIFY PERPETRATORS. LEFT OPPOSITION AT THIS POINT IS NOT EMBRACING HUAMAN. BUT IT APPEARS TO RESPECT HIS OBJECTIVES AND IS GIVING HIM BENEFIT JORDAN OF DOUBT.
