

JNE OFFICE LOCATED AT COOPERATIVE IN SAN JUAN DE LURIGANCHO (A WORKING CLASS AREA ACROSS RINAC RIVER FROM DOWNTOWN LINA). FIVE TERRORISTS REPORTEDLY WERE IN THIS BAND WHICH. AS IN CASE PREVIOUS DAY. TORCHED REGISTRATION MATERIALS IN OFFICE AND ATTEMPTED TO DESTROY IT WITH A ALTHOUGH TERRORISTS FIRED HALF-DOZEN DYNAMITE CHARGES. SHOTS, EIGHT CIVILIANS WOUNDED THERE APPARENTLY ALL WERE HURT AS RESULT OF EXPLOSIONS. (U) BUT SENDERISTAS PAID A PRICE FOR THESE INCIDENTS. LIMA PRESS REPORTED CAPTURE OF "TEN SUSPECTS" IN AFTER-MATH OF OCT. 26 ATTACK. OF PROBABLE GREATER SIGNIFICANCE, HOWEVER, POLICE FOLLOWED-UP OCT. 27 ATTACK BY IDENTIFYING TWO SUSPECTS WITHIN HALF-HOUR OF INCIDENT SHOOTOUT THAT DEVELOPED (BOTH INDIVIDUALS WERE ARMED) ONE DIED AND SECOND WAS CAPTURED. FROM WOUNDS, AND HAS BEEN IDENTIFIED AS A LAW STUDENT AT (LIMA) UNIVERSITY OF SAN MARCOS. OSCAR BRUSH NOEL PROMISED (OCT. 30) THAT APPROPRIATE INTERROGATION WOULD TAKE PLACE. ONCE PATIENT'S HEALTH PERMITS. BRUSH ALSO ANNOUNCED THAT POLICE PROTECTION OF JNE REGISTRATION OFFICES WILL BE AUGMENTED. 3. (C) COMMENT: SL'S BACK-TO-BACK ATTACKS ON LIMA AREA VOTER REGISTRATION OFFICES WAS NOT JUST A COINCIDENCE. WE SUSPECT SL WOULD LIKE TO DERAIL THE ELECTORAL PROCESS. AND EFFORT TO IMPEDE VOTER REGISTRATION IN LIMA FORMS FIRST PART OF WHAT MAY BECOME MORE DELIBERATE CAMPAIGN LATER ON. FRUSTRATE 1985 ELECTIONS IN THIS WAY AND ITS ABILITY TO DO SO LIES A LARGE GAP. SENDERO'S PRESENCE IN LIMA IS INDISPUTABLE. BUT IT ALSO IS CLEAR THAT POLICE HAVE ON REPEATED OCCASIONS CRACKED SL'S ORGANIZATIONAL INFRASTRUCTURE IN METROPOLITAN AREA. MAKING PLANNED.
