(U) GROUPS OF SENDERO LUMINOSO (SL) TERRORISTS STRUCK IN COORDINATED FASHION BETWEEN 9-10 P.M. EVENING FEBRUARY 21 AT SCATTERED SITES AROUND METROPOLITAN LIMA. NO CASUALTIES WERE REPORTED AT TWO SUBURBAN BANK BRANCHES HIT BY DYNAMITE BLASTS. OR AT THREE NEIGHBORHOOD HEADQUARTERS OF POPULAR CHRISTIAN PARTY (PPC) AND ONE OF GOVERNING POPULAR ACTION (AP). ALSO APPARENTLY SUSTAINED EXTENSIVE DAMAGE. MORE SERIOUS INCIDENT, HOWEVER, INVOLVED SHOOTOUT BETWEEN POLICE AND GROUP OF FOUR SENDERISTAS ATTEMPTING TO DYNAMITE TELEPHONE COMPANY INSTALLATION. SENDERISTAS ESCAPED, TWO DIED, AND FOURTH WAS WOUNDED ONE POLICENAN REPORTEDLY WAS INJURED WHEN A DYNAMITE CHARGE STRUCK HIM IN THE FACE (BUT DID NOT EXPLODE). POLICE DISCOVERED NUMEROUS OTHER UNEXPLODED CHARGES IN THE VICINITY. 2. (U) A THIRD DEATH OCCURRED AT 10:30 P.M. 3. (C.) COMMENT: DESCRIBED INCIDENTS ARE PROBABLY
THE OPENING SALVO IN SENDERO'S OWN "ELECTORAL
CAMPAIGN." WE SURMISE THAT SL WILL RESPOND TO CURRENT
NATIONAL EXERCISE OF POPULAR SOVEREIGNTY VIA THE
BALLOT BOX IN SAME FASHION IT RESPONDED TO MUNICIPAL
